Participation – General

Participation in the Promotion is available to:

Participation – Residency Restriction

Participation – Age Restriction

For single person participants, participation in the Promotion is only available to persons over 18 years of age.

Promotional Period

How to Participate

To participate in the Promotion, each participant must:

- i. enter into a contract of sale for an eligible untitled lot ($\geq 300\text{m}^2$) at Botanical Mickleham; and
- ii. pay the full deposit required under the contract of sale;
 - (a) comply with the terms of the contract of sale at all times without default;
 - (b) when the lot receives title, complete settlement within 10 business days;
 - (c) not delay or extend settlement beyond the required timeframe.

Qualifying Lots

The promotion applies to selected untitled lots at Botanical Mickleham that are 300m² or larger, available for sale during the Promotional Period. Lots under 300m² are not eligible for the rebate. Speak to a Sales Professional for specific lot details.

Rebate Amount

A rebate of \$10,000 (including GST). The rebate will be applied to the purchase price payable by the participant to Satterley and offset the purchase price as an adjustment in favour of the participant at settlement.
